

Installation Instructions for Sage 100 2020.6 (6.20.6.0)

Installing Sage 100 2020 Update 6 may require your Sage 100 2020 Workstation to be reinstalled.

1. Install Sage 100 2020 Update 6 on the Sage 100 2020 server.
2. Run Sage 100 on all your workstations. After completing the workstation sync, the following message may display requiring the Sage 100 2020 Workstation to be uninstalled and then reinstalled.



3. If you get this message, go to your system's Control Panel, Programs and Features and uninstall the Sage 100 2020 Workstation. Then run MAS90\WkSetup from the Sage 100 Server.
4. After reinstalling workstation setup, the workstation sync will run again, and this time successfully launch Sage 100.
