Sage Fixed Assets 2016.1

With this release, Sage continues to deliver value to our customers with continued tax updates to ensure regulatory compliance—so customers can confidently file their 2015 return. The Sage Fixed Assets 2016.1 release also includes additional product functionality.

Release features

Tax law changes

Among the tax changes that have been incorporated into Sage Fixed Assets 2016.1, most noteworthy is the inclusion of the "Protecting Americans from Tax Hikes Act of 2015" (PATH Act of 2015). The provisions in the PATH act include the permanent extension of the \$500,000 expensing amount for Section 179 and the 15-year life for qualified properties, the 5-year extension of bonus depreciation (168K special allowance), and the 2-year extension for several other special depreciation rules (that is, shorter depreciable lives for property on an Indian reservation).

On the Canadian tax front, Tax Class 53, "(50%) Manufacturing & Processing Equipment acquired after 2015 and before 2026" has been added for Canadian organizations.

User management

Sage Fixed Assets 2016.1 also introduces a new user management system for customers with multiple users, which enables them to easily activate and deactivate users from one central interface. This will not only help these customers to manage their users better, it also ensures that only authorized users can access the system. This feature applies to Depreciation and Tracking (Network and Premier versions). Single-user systems are not affected by this change.

To view seat usage from within Depreciation or Tracking:

- Select Help; Registration to open the Product Registration window.
- By default, if you have more than one Sage Fixed Asset product, the first one is highlighted. If needed, highlight the one you want to view.
- Click View Seats to open the Seat Information window.

System Administrators can manage seat usage from the Registration window located on the Premier or Network Server.

For Premier, open the Registration—Premier Depreciation & Tracking application.

For Network, open the **Database Utility—Network Depreciation & Tracking** application and click the **"Registration . . .**" button.

Global Task Manager (Premier Depreciation only)—Issue when reports are sorted

Fixed an issue where PDF exports from three reports were blank if they had a sort specified. The reports are: Fixed Asset Summary, Annual Projection, and Monthly Projection

Depreciation Calculation (Premier Depreciation only)—RV method with Begin Field information

Fixed an issue where the depreciation calculation was incorrect for assets using the RV method, with a Begin Date and Disposal date in the same fiscal year.
