# Depreciation

## **Tax Updates**

Stay compliant with your depreciation deduction on your U.S. Income Tax return.

Sage has included the following important tax compliance updates in this release. These updates apply to all Depreciation products.

#### U.S. Companies only

- The maximum Section 179 deduction increased \$30,000 to \$1,250,000 for tax years beginning in 2025. You can use the Audit Advisor or the Tax Expense report to check how much Section 179 you have claimed across all assets in a tax year.
- The Section 179 threshold amount is \$3,130,000 for assets placed in service in tax years beginning in 2025. This is an increase of \$80,000 over the 2024 threshold.
- The maximum Section 179 deduction for Sports Utility Vehicles (SUVs) increased \$800 to \$31,300 for tax years beginning in 2025.
- The annual depreciation caps for Automobiles (property type A) and Light Trucks and Vans (property type T) placed in service during 2025 have decreased compared to the 2024 depreciation caps.
- IRS Form 4562–Depreciation and Amortization supports both 2023 and 2024 tax years. Noncalendar year companies can update to this release for the latest tax compliance and features and still run a fileable form for 2023.
- The Audit Advisor is updated for validating your assets for tax years beginning in 2025. The Audit Advisor quickly checks for common U.S. tax compliance issues. It is accessed from the Depreciation Menu.
- 40% 168 Allowance (first-year bonus depreciation) added for qualifying assets placed-inservice in 2026.
- 20% 168 Allowance (first-year bonus depreciation) added for qualifying assets placed-inservice in 2026 and 2027.

If your preference is set to activate the last open company on startup, reopening the application will bring you back to the same company with the exact Group selected in the Asset List from your last session. This enhancement allows you to effortlessly and quickly continue your work, improving overall workflow efficiency.

## Rotate image when viewing\*

A Rotate button has been added to the Image Tab and Full Screen Viewer, allowing you to easily rotate images as you view them. This feature provides greater flexibility in examining images from different angles, improving your ability to interact with and analyze visual content.

## Microsoft ODBC Driver 17 for SQL Server update\*

Sage Fixed Assets Premier has been updated to use Microsoft ODBC Driver 17. This update includes enhanced security protocols, provides compatibility with newer database versions and SQL standards, and improves the application's database connectivity.

# **Defect Fixes**

With this release, Sage made the following defect fixes to the indicated Sage Fixed Assets products. Fixes with no specific product notation apply to all products that include the feature.

#### Sage Intacct: Entities with non-numeric IDs do not display in SFA Integration setup

Subscription licenses only

Fixed an issue where Sage Intacct Entities that contained alphabetic characters did not display in the entity list of the Sage Intacct Setup dialog in Sage Fixed Assets. Now, all qualified Sage Intacct entities display in the list.

#### Batch Reports: "Index was outside the bounds of the array." error

Sage Fixed Assets—Depreciation (Premier, Network, and Standard)

Fixed an issue where an "Index was outside the bounds of the array." error occurred when running Batch Reports with a Monthly Projection report.

# Print Asset Detail does not print asset information for all selected assets

Fixed an issue where asset information for some assets was skipped when running Print Asset Detail for a group of selected assets. Now, asset information for all selected assets displays.

#### Network Database Utility "System Database Connection Error"

Sage Fixed Assets—Network Database Utility

Fixed an issue where a "System Database Connection Error" occurred in the Network Database Utility. This defect occurred after changing the engine name, which led to a SQL loop issue, and subsequently corrupted the password.
